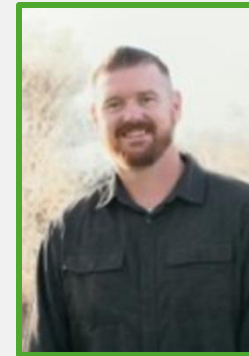

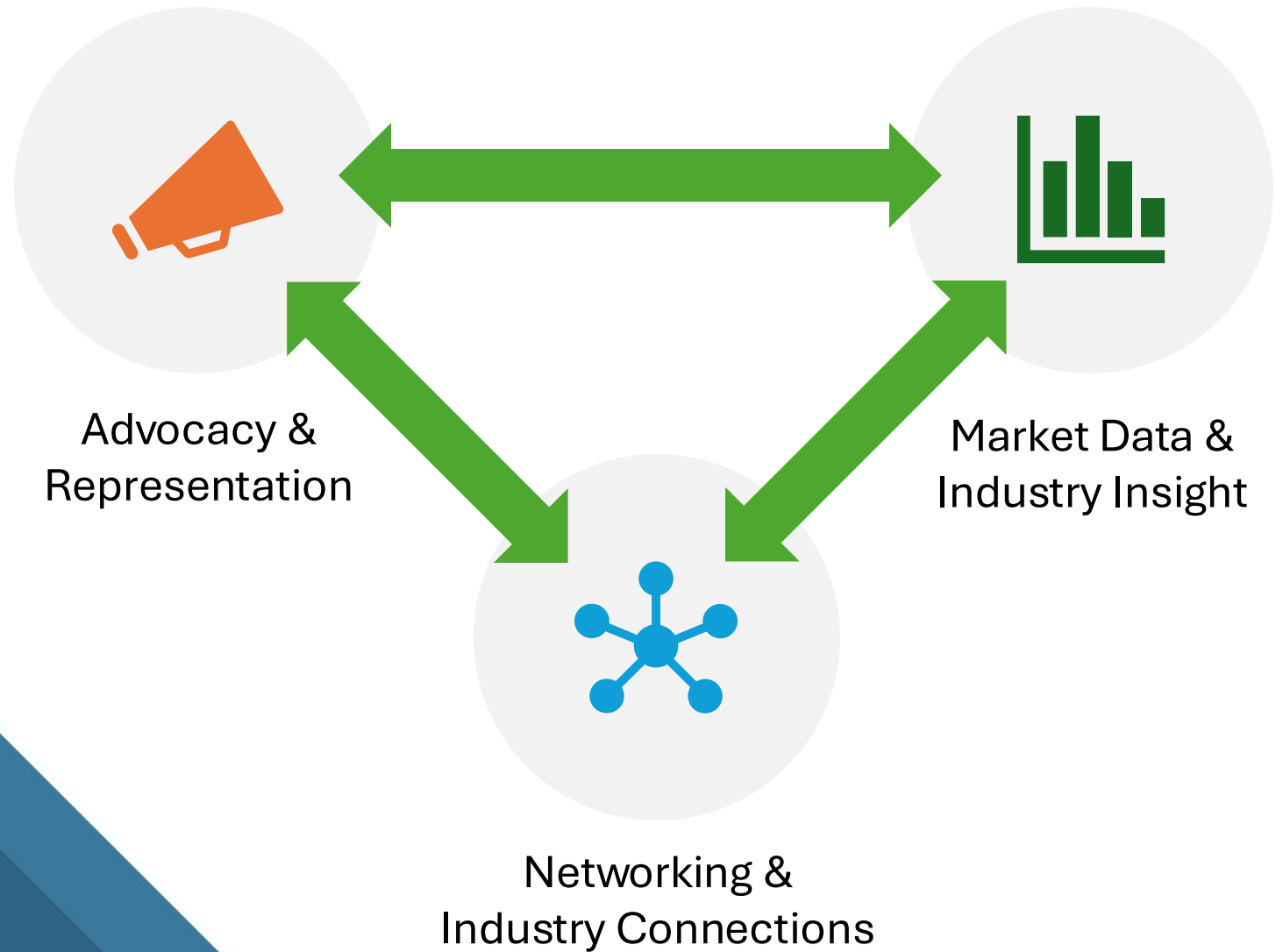

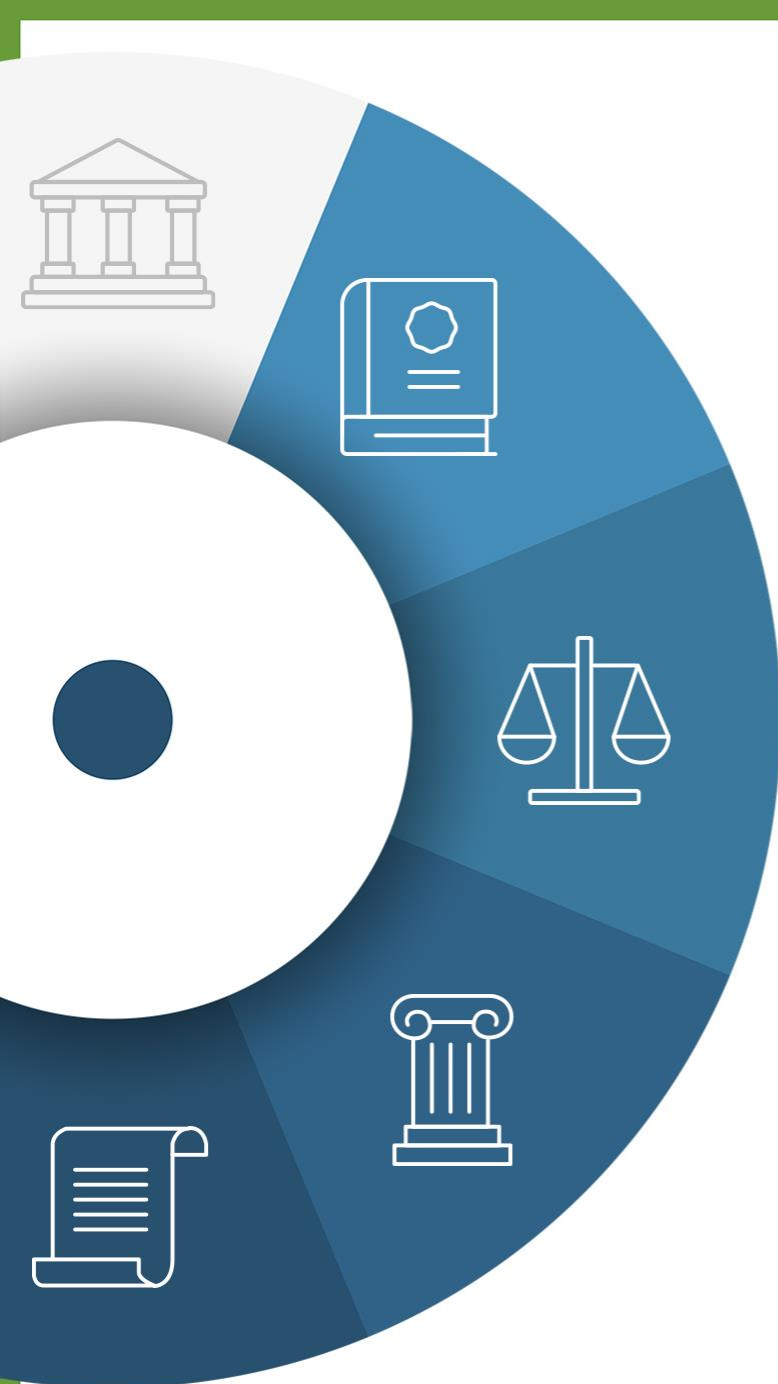

Past Legislative Efforts

Below are a few examples of key legislative victories over the past years

Assembly Bill 1253 (Santiago-D) Personal income taxes: additional tax. – Oppose

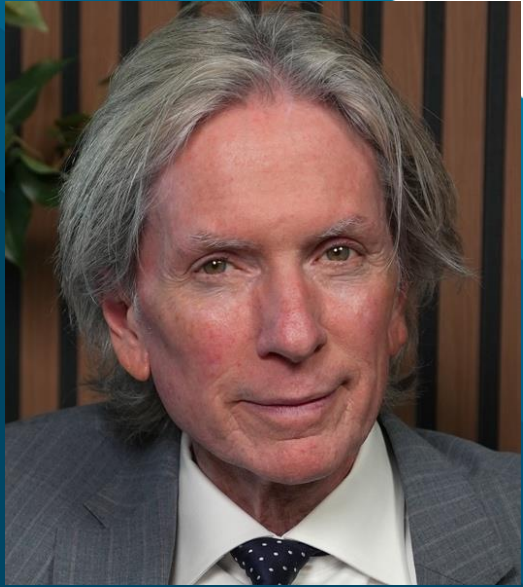
- Would have Imposed an additional tax on higher-income taxpayers.
- Stopped in Senate

Senate Bill 1141 (Wilk-R) Consumer protection. – Oppose

- Would have made negative changes to the Tanner Consumer Protection Act.
- Stopped in Senate

Assembly Bill 759 (Linder-R) Recreational vehicles. – Support

- Authorizes RV dealers to sell remaining inventory after a franchise agreement ends.
- Signed by the Governor

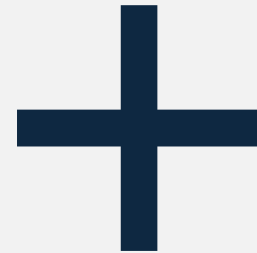

- **The problems that need addressing are not going to go away**
 - **California Compliant Generators** – Improving messaging surrounding CA Air Resources Board (CARB).
 - **Future Use of Diesel** – Navigating the uncertainties of CA's fossil fuel mandates.
 - **Exacerbated Lemon Law & ADA** – Issues that remain harmful to dealers and manufacturers.
 - **Insurance Availability & Cost** – Disincentivizes RV sales.

Memberships

(Full or Monthly Payment Plans Available)

Dealer Membership: Voting Members - \$2,500 (Covers 10 rooftops, +\$250 per additional rooftop)

- **Requirements:** A recognized RV dealer with a dealer's license. To be a Dealer Member of CalRVDA or on out-of-state associate member, you must also be a member of the national association, RVDA.

Associate Membership: Non-Voting Members, Included on CalRVDA Website - \$3,000

- **Requirements:** A business enterprise which is involved in or with the recreation vehicle industry in California in a capacity other than at retail, and which is not required to have a dealer's license. (e.g., banks, suppliers, and non-sponsoring manufacturers)
